**I/we certify, under penalty of perjury, that the information stated herein is true and correct to the best of my knowledge, information and belief.**

Certain class vehicles (see reverse side) will be registered for two (2) years at the time they are titled or their registration is renewed. The 2 year registration does not apply to Class E truck vehicles in excess of 7,000 lbs.

**Payment:** Check or money order payable to the MVA. The check must include (1) Imprinted name and address, (2) driver's license number (soundex number), (3) home or work telephone number. Company checks must have the Federal Employer Identification Number (FEIN). Visa, Master Card, American Express and cash are acceptable for payment in person.

**Transferring Plates:** If the annual registration fee is the same or less than the fee for the previously owned vehicle, the transfer fee is \$10.00 plus any difference in the two registration fees. If you are transferring plates and less than 12 months remain before your registration expires, the registration will be renewed for an additional year.
